- An opponent who has overcalled (showing a 5-card suit) has fewer vacant spaces (8) than an opponent who just supported their partner with 3-card support (10 vacant spaces).
- An opponent who has led a 4-card suit against NT has more vacant spaces (9) than an opponent who could still have a 5-card suit.
- BUT perhaps the overcaller leads a singleton in a different suit and you realise that that gives his partner 5 cards in that other suit: then, you are comparing 6 vacant spaces to 8 and the probabilities are swayed!
